We are pleased to share the highlights of the third quarter 2020 initiatives in this issue of the newsletter. We started off with the review of quarter two 2020 performance to forge the way forward. Judiciary We finalized the Scorecard Research Initiative 2019 and are set to launch the Scorecard Report on 8th October 2020. The Judiciary Scorecard Research Initiative 2020 was rolled out in August with the training and deployment of Research Assistants across 24 courts to collect data relating to the performance of the Judiciary.

With the changing trends, we are leveraging technology to increase our social media presence through Vlogs summarizing different legal principles, CEPIL tweet chat initiative and #KnowTheLaw #KnowYourRights online campaign.

We are consistently expanding our reach and establishing partnerships both locally and internationally through collaboration with partners. At CEPIL, we believe that we need to constantly strengthen technical and leadership capacity of the team so the secretariat enrolled and completed an online course aimed at improving the team's writing skills.

Quarter Two 2020 Review Meeting

On 8th July 2020, the team had the quarter two review meeting to assess organization progress and lay out a way forward for the third quarter. This was followed by a team building session in the afternoon characterized by sharing a delicious meal and games.

Judiciary Scorecard Research Initiative 2019

Technical and judgment review teams were constituted to review the draft Uganda Judiciary Scorecard Report 2019. Following the review, the report was completed and is set to be launched on the 8th of October 2020 physically at Mestil Hotel and virtually via Zoom and Facebook. Judiciary Scorecard Research Initiative 2020

Twenty-four (24) research assistants were identified, trained on the research methodology on 4th August 2020 and placed in 24 selected court stations. Unlike the previous years where data was collected by filling out paper questionnaires, this year in light of Covid-19 pandemic we are leveraging technology using a mobile application called Kobo collect in the data collection process.

Strengthening Technical and Leadership Capacity of the CEPIL Staff

In this quarter, the team enrolled in an online with on Communication course nonprofitready.org, organisation that supports non-profit professionals and organizations by providing access to free sectorspecific learning so that they have the knowledge and resources to create transformative impact in their own communities. The course covered aspects such as; technical writing, editing, proof reading business documents and planning an effective presentation.

Empowering the Bar and Bench in EA in Partnership with the EACJ

CEPIL is implementing a project with the East African Court of Justice under the theme "enhancing the performance of the Judiciary in East Africa through empowering the Bar and Bench in East Africa". In this quarter, we contracted Tride BAC a consultancy firm to work with the EACJ to establish a strategy to promote the EACJ as a forum for promoting good governance, rule of law and protecting civic spaces

Public Interest Litigation

As reported in the last issue, CEPIL through ALP Advocates filed a case for judicial review before the High Court against the Attorney General (Miscellaneous Cause No. 91 of 2020) seeking to challenge the legality of the process making and passing the Electricity (Establishment and Management of the Rural Electric-ity Fund) Instrument, S.I No. 62 of 2020, and the scope of the powers exercised by the Minster of Energy and Mineral Development in making the provisions. Subsequently, on 25th September, 2020, Justice Musa Ssekaana declared that instrument invalid which was in favour of CEPIL.
